Mr. Hughes's role is expected to include, potentially, lobbying the legislative and executive branches of the United States with respect to political and security issues in Libya and the foreign principal or its affiliates; providing information to press and/or opinion leaders with respect to political and security issues in Libya and the foreign principal or its affiliates; contacting business interest or governments other than the United States with respect to political, economic and security issues with respect to Libya and the foreign principal or its affiliates and providing consultation, negotiation and mediation services. Adams Jones Law Firm, P.A. has not reached a definite agreement with Dickens & Madson Canada regarding the compensation for Mr. Hughes's services or other terms of service.
