1. Introduction.

During the reign of the former regime of Libya many assets of the State of Libya were misallocated and misused. The Transitional Government-Libyan has established a Commission for recovering of the Looted Funds which has been constituted by the Decree of the Council of Minsters No. 34/2012. 1.1. In December 2010 a shipment of Libyan money was flown into the premises of Brinks. The money is a sum of 7 billion US dollars which is still under your custody.

## 3. Demands

The applicant wishes from Brinks Southern Africa Pty. Ltd the following:

3.1 In terms of the permission given to the applicant, the latter wishes to repatriate the aforementioned sum of money by means of delivering the aforementioned sum of money to the Libyan Embassy in Pretoria, their address being as follows: Libyan Embassy in Pretoria, South Africa 900 Church Street Pretoria, South Africa

This is considered as actual repatriation of the aforementioned sum of money because under international law the premises of the Embassy form integral part of the territory of the Libyan State. Further this is considered as a fulfillment of your function as prescribed in Private Security Industry Regulation Act 56 of 2001.

- 3.2 The applicant requires Brinks Southern Africa Pty Ltd to declare any further assets which belong to the Libyan Government. The Promotion of Access to Information Act 2 of 2000 obliges your private company to provide information when it is required.
- 4. Finally, it is required from Brinks Southern Africa Pty Ltd to deal with the transfer of the transportation of the aforementioned sum of funds to
